Management Discussion of Fund Performance **Portland Global Balanced Fund**

INVESTMENT OBJECTIVE AND STRATEGIES

The investment objectives of the Portland Global Balanced Fund (the Fund) is to provide positive long term total returns, consisting of both income and capital gains by investing primarily in a portfolio of global fixed income and equity securities. The Fund seeks to provide income and capital growth while moderating the volatility of equities by investing primarily in a globally diversified portfolio of equities, American Depository Receipts, income securities, preferred shares, options and exchange traded funds (ETFs). The Fund may also invest over 30% in foreign securities in a manner consistent with its investment objective.

RISK

The overall risk level has not changed for the Fund. Investors should be able to accept a low to medium level of risk and plan to hold for the medium to long term.

RESULTS OF OPERATIONS

For the year ended September 30, 2022, the Fund's Series F units had a return of (2.0%). For the same period, the Fund's Blended Benchmark (which is a composite consisting of 60% MSCI All Country World Index and 40% FTSE Canada Short Term Overall Bond Index TR) had a return of (10.4%). For the full period since inception of the Fund on December 17, 2013 to September 30, 2022, the Fund's Series F units had an annualized return of 3.5%. For the same period, the Blended Benchmark had an annualized return of 6.0%. Unlike the Blended Benchmark, the Fund's return is after the deduction of its fees and expenses.

The Fund's net asset value as at September 30, 2022 was \$2.6 million. The top five sector holdings at September 30, 2022 was consumer staples, 26.2%; utilities, 18.7%; health care, 16.3%; consumer discretionary, 11.8%; and cash and other net assets (liabilities), 7.1%.

By geography, assets were invested in securities of issuers classified as United States, 54.6%; Canada, 11.4%; United Kingdom, 8.0%; cash and other net assets (liabilities), 7.1%; Switzerland, 6.2%; Denmark, 3.2%; Germany, 2.2%; Ireland, 1.9%; France, 1.8%; Bermuda, 1.8%; and Spain, 1.8%.

The top three contributors to the Fund's performance during the year ended September 30, 2022 were Consolidated Edison, Inc., Genuine Parts Company, and Johnson & Johnson. The bottom three contributors to the Fund's performance during the year ended September 30, 2022 were Coloplast A/S, Croda International PLC, and Fresenius Medical Care AG & Co. KGaA.

The sectors contributing positively to the Fund's return for the period were industrials (Marubeni Corporation), consumer staples (Hormel Foods Corporation), consumer discretionary (Genuine Parts Company), and utilities (Consolidated Edison, Inc.) The sectors contributing negatively to the Fund's return for the period were communication services (AT&T Inc.), financials (Cincinnati Financial Corporation), real estate (American Tower Corporation), health care (Fresenius Medical Care AG & Co. KGaA), information technology (Halma PLC), and materials (Croda International PLC).

We believe there will be opportunities to deploy cash in attractively priced equities throughout the remainder of 2022 and beyond. We expect central banks globally to continue to increase interest rates in order to reduce inflation. These actions will eventually create buying opportunities throughout equity markets. We look forward to taking advantage of these buying opportunities when they occur.

RECENT DEVELOPMENTS

The impact of the COVID-19 pandemic has already been reflected in securities prices so it is not expected to have any material impact on the investments in the Fund. The Bank of Canada increased its overnight interest rate to 3.25% on September 7, 2022. This was followed by the U.S. Federal Reserve increasing its overnight interest rate to 3.25% on September 21, 2022. We are aware of inflation that has exceeded the target 2% range in Canada and the United States. The likely cause for this overshoot is supply chains re-adjusting to global lockdowns due to COVID-19 and fiscal and monetary stimulus that have been applied within the financial system during the pandemic. If inflation observed remains above the target 2% range then central banks may continue to increase interest rates. Increasing interest rates reduce economic activity. If interest rates continue to increase, we will continue to monitor the yield curve to detect indications that a recession is predicted by the market.

Positions in the Fund are expected to be primarily large market-capitalization dividend global aristocrat equities with some Canadian preferred shares to take advantage of higher yields and more advantageous taxation than debt. We prefer defensive sectors such as utilities, real estate and consumer staples that will likely benefit from interest rate cuts in a poor economic environment. The Fund is currently well positioned to meet its investment objective for the medium to long term. We will continue to evaluate opportunities that we believe may generate income, enhance returns and/or reduce risk wherever possible.

RELATED PARTY TRANSACTIONS

The Manager is responsible for the day-to-day operation of and for providing investment management services to the Fund. The Manager receives a fee for providing these services. This is calculated daily based on the net asset value of the Fund and paid monthly. During the year ended September 30, 2022, the Manager received \$39,836 in management fees from the Fund, net of applicable taxes (September 30, 2021; \$51,028).

Any administrative services paid for or provided by the Manager are charged to the Fund and are grouped and presented by expense type in the statements of comprehensive income (loss). Depending on their nature, some expenditures are allocated to the Fund based on a variety of methods including net asset value or actual costs incurred. During the year ended September 30, 2022, the Manager was reimbursed \$14,133 for operating expenses incurred on behalf of the Fund, including amounts paid to affiliates, net of applicable taxes (September 30, 2021: \$17,612). The Manager absorbed \$156,830 of operating expenses during the year ended September 30, 2022, net of applicable taxes (September 30, 2021: \$137,197). Affiliates of the Manager provide administrative services associated with the day-to-day operations of the Fund. These affiliates of the Manager were reimbursed \$999 during the year ended September 30, 2022 by the Fund for such services (September 30, 2021: \$802).

The Manager and/or its affiliates and key management personnel of the Manager and their family (collectively referred to as Related Parties) may invest in units of the Fund from time to time in the normal course of business. Transactions to purchase or redeem units are made at net asset value per unit. Standing instructions from the independent review committee (IRC), as described below, were not required or obtained for such transactions. As at September 30, 2022, Related Parties owned 13,522 shares of the Fund (September 30, 2021: 13,963).

The Fund has received standing instructions from the Fund's IRC. The standing instructions constitutes a written recommendation from the IRC that permits the Manager to proceed with specific action(s) set out in the standing instructions on an ongoing basis as detailed in the annual IRC Report to Securityholders. The standing instructions are designed to ensure that the Manager's actions are carried out in accordance with National Instrument 81-107 - Independent Review Committee for Investment Funds and the Manager's policies and procedures in order to achieve a fair and reasonable result for the Fund. The IRC reviews reports periodically, at least annually, which assess compliance with applicable conflicts of interest policies and standing instructions.

Except as otherwise noted above, the Fund was not a party to any related party transactions during the year ended September 30, 2022.

The Board of Directors of the Manager is responsible for reviewing and approving the financial statements and overseeing management's performance of its financial reporting responsibilities.


Past Performance


Year-By-Year Returns

- 1. Prior to December 13, 2013 the Fund operated as Copernican British Banks Fund, a closed-end fund listed on the Toronto Stock Exchange under the symbol CBB.UN. On December 13, 2013 CBB.UN was Restructured, became a multi-class open end mutual fund, and changed its investment objectives and strategies. If the Restructuring had not occurred and the investment objectives and strategies had remained the same, performance since then may have been different.
- 2. Return for 2013 represents a partial year starting January 1, 2013 to September 30, 2013.
- 3. Return for 2014 represents a partial year starting December 17, 2013 to September 30, 2014.

Annual Compound Returns

The table below shows the historical compound returns of the applicable series of units and the blended benchmark consisting of 60% MSCI All Country World Index (the MSCI Index) and 40% FTSE Canada Short Term Overall Bond Index TR (the FTSE Index). The MSCI Index is designed to measure the performance of the large and mid cap segments across developed and emerging markets. The FTSE Index is a measure of total return of Canadian bonds which have a term to maturity of one to five years. The blended benchmark provides a useful comparison to the performance of the Fund. Performance will vary by series largely due to the extent that fees and expenses may differ between series.

Comparison to the Blended Benchmark: Since the Fund does not necessarily invest in the same securities as the blended benchmark or in the same proportion, the performance of the Fund is not expected to equal that of its blended benchmark. Please refer to Management Discussion of Fund Performance - Results of Operations for additional discussion of the Fund's performance compared to the blended benchmark.

Management Fees

The Manager is responsible for the day-to-day management and administration of the Fund. The Manager monitors and evaluates the performance of the Fund, pays for the investment management services of the portfolio adviser and arranges for the administrative services required to be provided to the Fund. As compensation for its service, the Manager is entitled to receive a fee, payable monthly, calculated based on the average daily net asset value of the Fund.

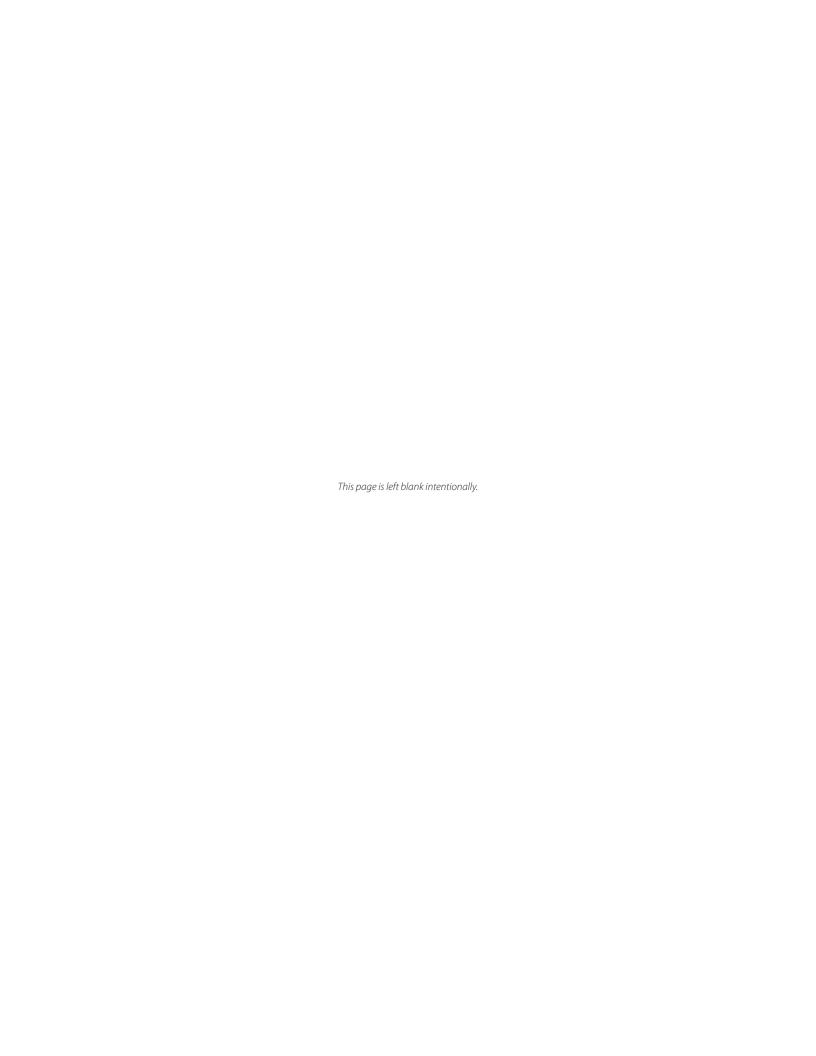
- The information is derived from the Fund's audited annual financial statements prepared in accordance with International Financial Reporting Standards. The net assets per security presented in the financial statements may differ from the net asset value calculated for fund pricing purposes.
- Net assets and distributions are based on the actual number of units outstanding at the relevant time. The increase/decrease from operations is based on the weighted daily average number of units outstanding over the financial period.
- Distributions are paid out in cash/reinvested in additional units of the Fund, or both.
- 4. This is not a reconciliation of the beginning and ending net assets per unit.
- 5. The management expense ratio (MER) is based on total expenses (excluding foreign withholding taxes, commissions and other portfolio transaction costs but including management fee distributions paid to certain unitholders in the form of additional units) for the stated period and is expressed as an annualized percentage of daily average net asset value during the period. The Manager may absorb certain expenses otherwise payable by the Fund. The amount of expenses absorbed is determined annually at the discretion of the Manager.

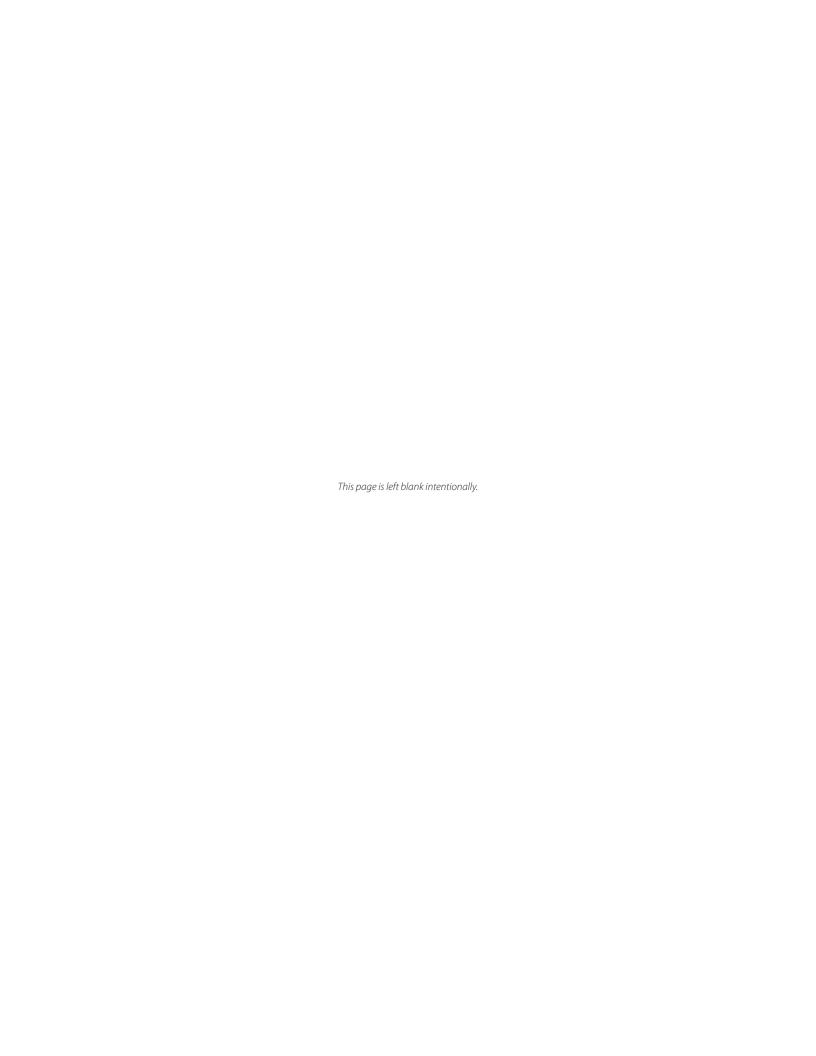
The Fund may hold investments in exchange traded funds (ETFs). The MER is calculated taking into consideration the expenses of the Fund allocated to the series including expenses indirectly attributable to its investment in the ETFs divided by the average daily NAV of the series of the Fund during the period.

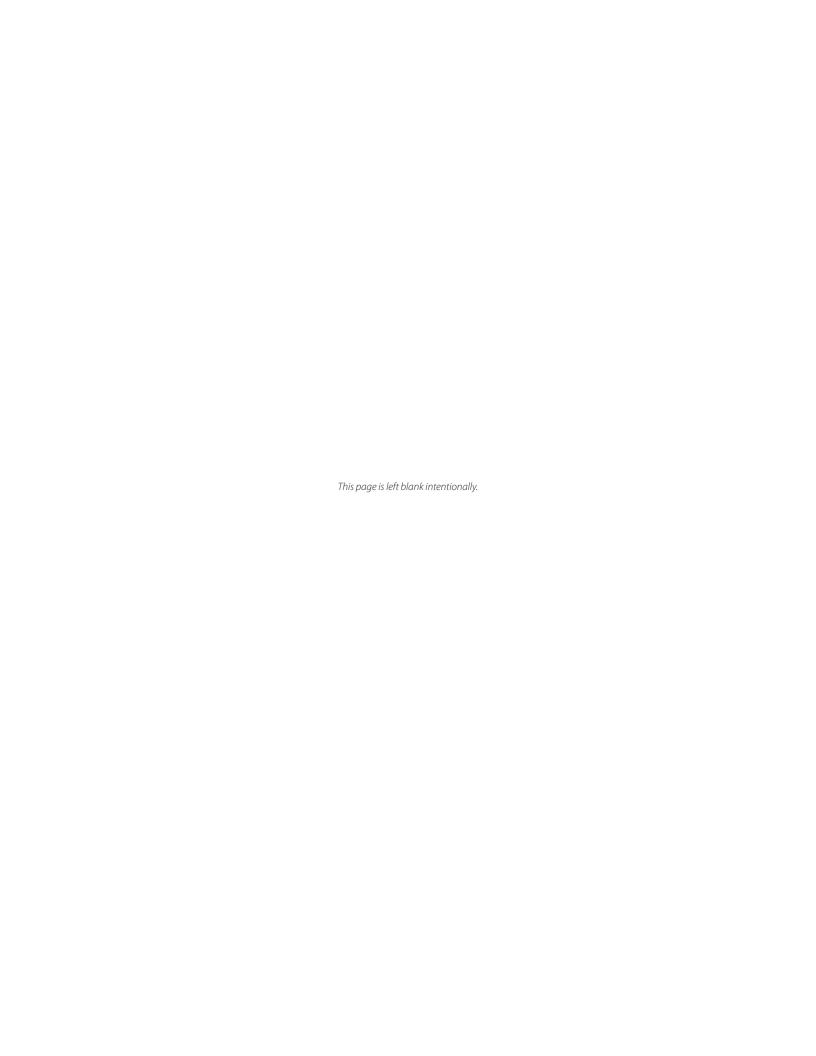
On April 20, 2020, the management fees decreased from 1.65% and 0.65% to 1.55% and 0.55% on Series A and Series F, respectively. For the year ended September 30, 2020, if the change in management fees had been effective since the start of that financial year, the MER after waivers or absorptions would have been 2.34% and 1.21% Series A and Series F, respectively.

- The trading expense ratio (TER) represents total commissions and other portfolio transaction costs expressed as an annualized percentage of the daily average net asset value of the Fund during the period.
 - The TER is calculated taking into consideration the costs attributable to its investment in ETFs.
- 7. The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to a fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Portfolio turnover rate is calculated based on the lesser of the cumulative cost of purchases or cumulative proceeds of sales divided by the average market value of the portfolio, excluding short-term investments.
