# PORTLAND 15 OF 15 ALTERNATIVE FUND

## NEWS UPDATE

**Danaher Corporation**, a leading provider of medical equipment and a holding of Portland 15 of 15 Alternative Fund, announced the acquisition of Aldevron for US\$9.6 billion, in a push to capture the growth experienced in the gene and cell biological production, most commonly known for delivering the building blocks for the innovative mRNA vaccines. This is one of Danaher's largest acquisitions, behind Cytiva, the former lifesciences business of GE Healthcare, and Pall Corporation only and yet another testimony of the company's mergers and acquisitions prowess in finding areas of expansion. Aldevron is a private company headquartered in Fargo, North Dakota, and will join Danaher's rapidly growing Life Sciences segment.
